All submitted abstracts will undergo peer review. The abstract should clearly indicate the aims and conclusions of the work to be described in the final paper. Abstract text length should not be more than 350 words and should be in English.

Note: Papers (abstracts and full papers) must be saved in MS Word format and submitted as an attachment and emailed to cu-ice@covenantuniversity.edu.ng. All papers must follow APA format which can be viewed at <http://www.apastyle.org/>. Each paper will undergo a double-blind peer review process. Acceptance will be based on quality, relevance and originality.
